

AGREEMENT TO ABIDE BY ALL POLICIES, RULES AND REGULATIONS

Season Pass Purchase Guidelines:

- Season Pass will be valid from March 23, 2024 – November 11, 2024.
- The cost for each Season Pass is \$150 per member.
- Season Pass will be sold for 1-5 members. If a sixth pass is needed an additional single can be purchased.
 - For Example. Choose which category applies to your purchase:

One Member Season Pass is for one singular person. Cost \$150 plus taxes and fees

Two Member Season Pass is for two people (i.e. child & adult). Cost \$300 plus taxes and fees

Three Member Season Pass is for three people (i.e. one child & two adults or two children and one adult). Cost \$450 plus taxes and fees

Four Member Season Pass is good for up to four people (a mix of children and adults). Cost \$600 plus taxes and fees

Five Member Season Pass is good for up to five people (a mix of children and adults). Cost \$750 plus taxes and fees

- VERY IMPORTANT: Only one QR Code per email address.
- Children under 15 months do not require a pass unless during the time of use the child becomes of age.
- Season Passes are only available for purchase online.
- Once purchased you will receive a confirmation email containing your Season Pass QR Code and instructions to email pictures of the members associated with the QR Code. The QR Code will be what you will need to enter the animal farm, however it will not be valid until photos of members are received and uploaded.
- You will receive ONE QR Code for all members.
- The Season Pass cannot be shared with non-members or it will be revoked without a refund.

Season Pass Policy:

- The Season Pass is valid for one person only.
- The Season Pass cannot be shared or it will be revoked without a refund.
- The Season Pass is not valid for Fall Festival Weekends and Columbus Day.
- Management reserves the right to terminate the Season Pass at any time with no refund.
- Season Pass members will not be admitted without showing the QR Code associated with their name.
- Upon first use of the Season Pass; purchaser must be present and show valid license and the credit card used when purchase was made to White Post Farm representative in order to pick up and activate season pass.
- Season Pass is based on our general animal farm admission only. Special events such as shows, entertainment and character appearances are not guaranteed at any time. If such an event does occur on the date of your admission, we will however honor your pass on that day.
- Certain blackout dates will apply. i.e. Fall Festival days.
- As the purchaser I will or I have obtained permission from the legal parent/guardian of the participant(s) for which I am purchasing the season pass to execute this agreement on their behalf. I agree that the participant(s) and I shall comply with all stated and customary terms, posted safety signs, rules, and verbal instructions as conditions or

being a season pass member while on the property of White Post Farms. I agree to take full responsibility for any and all damages to the facility and any of its contents arising from any of my party refusing to follow all stated and customary terms, posted safety signs, rules, and verbal instruction including any deliberate acts of damage or destruction.

RULES & REGULATIONS FOR ALL WHITE POST FARM GUESTS

- **Release of Liability:** I am aware that there are inherent risks that may arise while on the grounds of White Post Farms including but not limited to accidents that may occur with use of playgrounds, pony rides, train rides, interactions with animals, or falls on any surfaces while on White Post Farms property and I, on behalf of myself and the participant(s) knowingly and freely assume such risks, both known and unknown, including those that may arise out of the negligence of other participants; and I, for myself and the participant(s) and our respective heirs, assigns, administrators, personal representatives, and or next of kin, hereby release and hold harmless, White Post Farms, and their affiliates, officers, members, agents, employees, other participants, and sponsoring agencies from and against any and all claims, injuries, liabilities or damages arising out of or related to participation in any acts while on the grounds of White Post Farms.
- **Hours of Operation:** Parks, services, entertainment and attractions may change operating hours, close temporarily, or may otherwise change or be discontinued without notice and without liability.
- **Not Allowed on Farm Grounds at any Time:** Scooters, roller skates, dogs, cats, balloons, concealed weapons, baseball bats, or other sporting equipment are not allowed on farm grounds. Throwing of rocks, sand, or dirt on playground equipment or other guests is also prohibited. Smoking is not allowed anywhere while on the property of White Post Farms. Anyone caught smoking on farm grounds will be asked to leave for the day.

All Encompassing Disclaimer

You (and on behalf of your child(ren) and guests) voluntarily assume all risks of personal injury (including but not limited to death) loss/damage to property (stolen or otherwise), and all hazards incidental to attending the White Post Animal Farm and/or affiliated events and using their rides, attractions and facilities, and agree that White Post Animal Farm, LLC, and all affiliated entities (the "Farm"), their members, managers, officers, employees and agents are not responsible for and shall not be liable for any such injuries or losses.

To the fullest extent allowed by law, you are forever releasing, waiving, discharging and covenanting not to sue on your behalf or on behalf of the child(ren) and guests; and if the child(ren) or any guests or anyone on behalf of the child(ren) or guests makes a claim or takes any legal action against the Farm, its members, managers, officers, employees or agents, your signature represents that you will indemnify, defend and hold harmless the Farm, their members, managers, officers, employees and agents from any and all claims, actions, suits, procedures, losses, liabilities, damages, costs, expenses (including reasonable attorneys' fees) and other litigation expenses arising from such claims and/or actions.
